Board Resolution

CCMRA Membership

Per Chapter 355 Nonprofit Corporation Law Section 355.821 Corporate Records: the Board of Directors must adopt a Resolution relating to the characteristics, qualifications, rights, obligations, and limitations for members.

We the CCMRA Board of Directors herby certify that the following is a true and correct copy of a resolution duly adopted at a meeting of the CCMRA Board of Directors duly held and convened on February 18, 2023, at which a quorum of the Board of Directors was present and voting throughout, and that such resolution has not been modified, rescinded, or revoked, and at present is in full force and effect:

Therefore, it is Resolved that the following articles derived from the CCMRA bylaws explain the characteristics, qualifications, rights, obligations, and limitations for CCMRA members:

ARTICLE 1. Membership Characteristics: To be a CCMRA member one must be of virtuous character as demonstrated by their wisdom, courage, kindness, good manners, courtesy, modesty, generosity, and self-control. They treat others fairly, esteem others highly and value the sanctity of life. They treat others better than they are treated. They demonstrate their virtue by good, moral ethics and making moral and ethical choices in life.

ARTICLE 2. Membership Qualifications: To be a CCMRA member *in good standing* one must be a registered Christian County Voter that is faithful to the Republican Party Platform and Constitutional Republican Values. That is of virtuous character as outlined in Article 1 above. That has been successfully vetted and approved by the Membership Committee and the Executive Committee and has paid their membership fees.

ARTICLE 3. Membership Rights: CCMRA members *in good standing* have the right to attend the meetings of the assembly. To make motions. To participate in debate and to vote on all issues brought before the membership. Members have the right to seek an officer position and become a delegate to a district or state convention. Members have the right to sponsor new member applicants. Members have a right to due process for discipline issues before the Board of Directors and

the membership. Members have a right to an appeal process for any incurred discipline.

ARTICLE 5. Membership Obligations: Members are expected to attend all meetings and bring their personal copy of the agenda to the meeting. Pay their dues at the appointed time. Membership carries with it basic duties, such as the duty to vote on questions on which the member has an opinion. To read and be aware of the CCMRA bylaws. To be of service to the CCMRA by participating as a member of an authorized committee or program. To engage in municipal, county, and state elections as well as legislation. To be familiar with Robert's Rules of Order.

ARTICLE 6. Membership Limitations: No member gets more than one vote per issue. There will be no proxy or cumulative voting. Members may not align themselves with another political party. Members may not misuse their name and office or membership status to publicly effect non-support or sanction against any Republican candidate in a general election. Members may not prematurely endorse a candidate or issue before action by the CCMRA's Board of Directors. Members must not violate the rules established by the CCMRA bylaws.
